Please contact AARP for a rate quote, or follow the instructions on page 34 of this enrollment guide to obtain a very approximate quote based on 2016 rates. **If you choose to enroll in the UNM-sponsored AARP plans, you MUST coordinate your enrollment with UNM Human Resources office by using the Authorization Form on page 36 of this guide to request an enrollment kit(s).**
