- If I have any specific questions about my child's participation, safety or the risks associated with working in the Program, I understand that I should speak to UNM Human Resources.
- I acknowledge that there are risks associated with the aforementioned activities, including, but not limited to, personal injury or loss resulting from or arising out of participation in the designated activities. I agree to assume all risks of personal injury or bodily loss resulting from or arising out of the participation in the designated activity. I also release, waive, indemnify, hold harmless, and discharge UNM, its Board of Regents, its officers, employees or agents from any and all claims, damages, and injuries that arise out of the Program.
