### **ACTION ITEMS:**

1. Call to Order, Confirmation of a Quorum, and Adoption of Agenda – *Nicole Dopson, Chairperson* 

Meeting called to order at 9:00 a.m. in Roberts Room, Scholes Hall. Confirmed that a Quorum was established. Dorothy Anderson moved to adopt agenda and Fran Wilkinson seconded. The motion passed by unanimous vote.

2. Quarterly Investment Results – *Jerry Sais and Sean Walker, Bank of Albuquerque Representatives* 

Presentation was held to cover return portfolios through 2018 and an update of current 2019 portfolios (Presentation materials provided to committee members and posted online).

3. Review of Committee Membership and Meetings – *Dorothy Anderson, VP of Human Resources* 

Annual Notice of Meetings Document for VEBA: Dorothy Anderson will discuss with Patrick Hart in Legal Counsel about revising this document, and determine if it should be posted annually.

In 2015, former President Frank signed an amendment stating that every odd year, membership of the committee would be reviewed. VEBA will wait until June for next Faculty Senate President, and Staff Council President, to route current names for recommendation; this will go to the President for final approval. Two Faculty, two Staff

Council, and two Presidential appointees. We will also determine a new Chair, Secretary, and Treasurer after members are appointed.

 NOTE: Positions that are identified as VEBA committee members in the VEBA document will continue and remain as committee members – Dorothy Anderson, Liz Metzger, and Craig White.

VEBA meetings should take place quarterly. Meetings need to be reinstated on a quarterly schedule.

Kevin Stevenson and Joey Evans will be attending VEBA meetings as non-voting members.

### 4. UNM Post-Retirement Benefits Subsidy Proposal – Joey Evans, Benefits Director

Joey Evans discussed VEBA Plan Administration Updates & Approvals handout. He explained the request for approval for 1. Approval UNM Subsidy for Pre-65 Retirees found on pg. 1 of handout. NOTE: Tabled until further information and data can be provided to committee members at the next VEBA meeting.

## 5. Break in VEBA Contributions due to LWOP – Joey Evans, Benefits Director

Benefits Director, Joey Evans, continued his presentation by going over the second request for 2. Approval: Five Consecutive Years of Contributions Requirements, see pg. 2 of plan document.

 Request approved to allow, as a standard interpretation, a break in VEBA Service/Contributions due to LWOP. Denece Kesler moved to approve and Gene Henley seconded. The motion passed by unanimous vote.

# 6. Request to Restate VEBA Trust & Plan Documents in FY20 – *Joey Evans, Benefits Director*

The final request on the plan document discussed was 3. Approval: Future VEBA Plan Document Restatement, found on pg. 2. Final VEBA Plan documents will be presented to the VEBA committee prior to adopting.

 Request approved to Restate VEBA Trust & Plan Documents in CY20. Gene Henley moved to approve and Fran Wilkinson seconded. The motion passed by unanimous vote.
